1. MANAGED CARE OPPORTUNITY ASSESSMENT (UPDATED 12-13-24)

Florida operates significant portion of its Medicaid program through a comprehensive Section 1115 demonstration (effective through June 2030). The state's traditional Managed Medical Assistance (MMA) plans cover acute care and comprehensive plans cover both acute and long-term care. Specialty plans cover child welfare, HIV/AIDS, and serious mental illness.

The Florida Agency for Health Care Administration (AHCA) released its Statewide Medicaid Managed Care Program (SMMC) Invitation to Negotiate (ITN) in April 2023, for the MMA program and for its Managed Long-term Care program. Under the new procurement, specialty plans were awarded to a comprehensive or MMA plan, rather than separately as they had been previously. The procurement encompasses more than 3.4 million Medicaid beneficiaries and is valued at \$120 billion to \$150 billion over five years through December 31, 2030.

In April 2024, the state awarded contracts to five incumbent plans: Florida Community Care, Humana, Elevance/Simply Healthcare Plans, South Florida Community Care Network/Community Care Plan, and Centene/Sunshine State Health Plan. Seven plans subsequently submitted formal protests to the Medicaid managed care awards: Aetna, AmeriHealth Caritas, Florida Community Care, ImagineCare—a joint venture between CareSource and Spark Pediatrics—Molina Healthcare, Sentara Care Alliance, and UnitedHealthcare. As a result of protests, in July 2024 Florida revised its contract awards to include contracts to CVS/Aetna, Molina Healthcare, and UnitedHealthcare. The state also revised awards for Florida Community Care and South Florida Community Care Network/Community Care Plan. See Section 3 for more details.

AmeriHealth Caritas, Sentara Care Alliance and ImagineCare did not secure contracts in the revised awards announced in July. These three plans also challenged the state's July revision to Medicaid contract awards in administrative court, but the plans have since dropped their protests.

Contracts are scheduled to be implemented in 2025 and run through December 31, 2030. Current contracts are effective through December 31, 2024.

In November 2024, Florida released an ITN for its Children's Medical Services (CMS) program, which provides SMMC and Children's Health Insurance Program (CHIP) services to about 88,000 children. The state intends to make a single statewide award in March 2025, and the contract will run from the date of execution through December 31, 2030. The incumbent is Centene/Sunshine Health.

The state enacted legislation in June 2023 to pilot Medicaid managed care for individuals with developmental disabilities in seven counties: Miami-Dade, Monroe, Hardee, Highlands, Hillsborough, Manatee, and Polk counties. Florida subsequently released an ITN to transition fee-for-service home and community-based waiver services for individuals with intellectual and developmental disabilities (IDD) to a pilot program for long-term care plans participating in the SMMC program. In February 2024, the state announced its intent to award Florida Community Care with the six-year contract. Elevance/Simply Healthcare also responded to the ITN. The initial phase of the pilot program will enroll up to 600 individuals in SMMC regions D and I and will run from the execution date through September 30, 2030.

Florida also released an ITN for the Statewide Medicaid Prepaid Dental Program in October 2023. In June 2024, the state announced its intent to award contracts to incumbents Liberty Dental Plan of Florida and DentaQuest of Florida. Contracts will run from the execution date through December 31, 2030. Incumbent MCNA Dental and new bidder Avesis were not awarded contracts.

Hot Topics

In September 2024, Florida announced its intent to submit an amendment to CMS that will align its MMA Section 1115 demonstration program with changes resulting from the state's 2023-2024 procurement of Medicaid managed medical care and dental plans. The requested changes include expanding the Behavioral Health and Supportive Housing Assistance pilot program, enhancing the MMA enrollment process, and transitioning certain services from MMA to the dental program. These changes will allow all members of a family who are enrolled in Medicaid to receive services under a single plan that provides MMA, Long-Term Care, and specialty product benefits.

In March 2024, Florida submitted a request for a new Section 1115 demonstration program, titled the "Children's Health Insurance Program Eligibility Extension," to extend eligibility for the state's CHIP, called KidCare, to children in households with income up to 300 percent of the federal poverty level. In December 2024, CMS approved the demonstration; however, the state rejected the expansion due to a federal provision requiring states to provide 12 months of continuous coverage. Florida is planning to request a 30-day delay on the demonstration to allow for the incoming Trump administration to review the policies. Florida previously filed a lawsuit over the mandate, and then filed an appeal after the initial lawsuit was dismissed.

2. MANAGED MEDICAID PLAN FINANCIALS

Average medical loss ratio among Managed Medical Assistance (MMA) Standard Medicaid managed care plans in Florida was 86% in 2023. Per member per month premiums averaged \$448.

3. RFP DEVELOPMENTS AND ANALYSIS

SMMC. In April 2023, AHCA released an Invitation to Negotiate (ITN) for its Statewide Medicaid Managed Care (SMMC) program, which includes the state's traditional MMA and Managed Long-term Care programs and covers 3.2 million Medicaid beneficiaries. As part of this procurement, the state consolidated the number of regions from eleven to nine. Among the changes under the new contracts, specialty plans were not awarded separately; instead, they were awarded to a comprehensive or MMA plan. Contracts are scheduled to run from 2025 through December 31, 2030.

The ITN identified several agency goals and areas of focus for this contract term, including improving maternal and child health outcomes, youth mental health, and home and community-based services. Voluntary recipients will be enrolled and have the choice of opting out of services. The MCOs are required to have community partnerships to provide services and supports in specified areas, including health-related social needs, birth outcomes, and mental health of children and adolescents.

The ITN also required bidders to address their experience with value-based purchasing (VBP) and evaluated the extent of a plan's attributed enrollees in higher level VBP arrangements. Under the new contracts, AHCA requires the managed care plans to develop and implement a VBP program and to use the Learning Action Network (LAN)'s alternative payment framework to categorize its VBP agreements with providers. The state also specifies a schedule for a minimum percentage of the MCO's payments to providers through VBP agreements.

In April 2024, AHCA awarded five of the eleven bidders contracts for the SMMC ITN. Florida received seven protests over the Medicaid managed care awards. Plans submitting protests were Aetna, AmeriHealth Caritas, Florida Community Care, ImagineCare, Molina Healthcare, Sentara Care Alliance, and UnitedHealthcare.

As a result of the protests, in July 2024, AHCA announced additional intents to award SMMC program contracts for three incumbent plans: CVS/Aetna, Molina Healthcare, and UnitedHealthcare. CVS/Aetna will serve regions D, E, and I; Molina will serve region I; and UnitedHealthcare will serve regions B, D, and I. Aetna and United will retain their current foothold, while Molina will serve Miami-Dade County and Monroe County, but no longer be in Region F.

The state also revised awards for Florida Community Care and South Florida Community Care Network/Community Care Plan. Under the revised awards, Florida Community Care will serve statewide in long-term care and as a comprehensive plan in Regions A, B, C, D, I. South Florida Community Care Network will serve regions E, F, G, H, and I as a Managed Medical Assistance Plus plan.

Previously awarded plans include Humana, Elevance/Simply Healthcare Plans, and Centene/Sunshine State Health Plan. (See below for a chart and map of bidders by regions.)

AmeriHealth Caritas, Sentara Care Alliance, and ImagineCare did not secure a contract in the revised awards. The three plans challenged the state's July and April Medicaid contract award decisions in administrative court, but ultimately dropped their protests.

In November 2024, Florida released an ITN for its Children's Medical Services (CMS) program, which provides SMMC and CHIP services to about 88,000 children. The state intends to make a single statewide award. Awards are anticipated on March 21, 2025. The contract term will begin the date of contract execution through December 31, 2030, with no renewal options.

The ITN requires respondents to outline innovative and evidence-based approaches in meeting goals under the Medicaid program, including improving mental health, promoting preventative health, enhancing care coordination; and utilizing a full array of services in the home to avoid institutional care. During the negotiation process, respondents may be provided an opportunity to recommend value added services, which are additional services provided that include new and innovative technologies relating to the telecommunication services sought under this solicitation. The current CMS program incumbent is Centene/Sunshine Health.



4. MANAGED CARE ENROLLMENT UPDATE

Medicaid managed care enrollment in Florida decreased 10.6% in August 2024, compared to year-end 2023, after decreasing 20.8% in 2023, increasing 11% in 2022, 11.3% in 2021, 18% in 2020 and decreasing 2.9% and 1.6% in 2019 and 2018, respectively.



5. MEDICAID FEE FOR SERVICE VS. MANAGED CARE PENETRATION

Total Medicaid enrollment in Florida was 4.2 million in 2023. About 87.3% of Medicaid beneficiaries were enrolled in a managed care plan. Total Medicaid expenditures in Florida were \$34.2 billion in 2023, with 74.2% through managed care.

6. SNPs and Dual Eligibles

Florida had 809,315 Special Needs Plan members as of March 2024. In 2024, the state contracted with 27 dualeligible special needs plans (D-SNP) covering 600,000 members. Of these members, half are eligible for full Medicaid benefits.

AHCA released on May 15, 2023, a request for information (RFI) for the state's dual-eligible special needs plan (D-SNP) program. Florida is considering moving the responsibility for providing Medicaid services from the D-SNP contracts to the SMMC program. Enrollment into the SMMC program would be mandatory for the full benefit dual-eligibles. As a result, D-SNP contracts would become Coordination-Only D-SNPs and D-SNPs would no longer receive a capitation rate for their full dual members. Over 300,000 members would be shifted to the Medicaid managed care program. The RFI is seeking information on whether the state should continue with Highly Integrated and Fully Integrated D-SNP contracts or move to Coordination-Only contracts.

AHCA has not publicly released the responses to the RFI or announced a decision on whether to continue with Highly Integrated and Fully Integrated D-SNP contracts or move to Coordination-Only contracts.
