# 1. MANAGED CARE OPPORTUNITY ASSESSMENT (UPDATED 9-20-23)

North Dakota operates a Medicaid managed care program for expansion members, with Blue Cross Blue Shield of North Dakota. The state awarded a three-year contract that began in 2022 with up to two one-year renewals.

The state also offers a Medicaid Primary Care Case Management program, serving the non-Medicaid expansion population, as well as a health management program and a Program of All-Inclusive Care for the Elderly (PACE). North Dakota also serves selected populations through six 1915 waivers: aged and disabled, autism spectrum disorder, children's hospice, medically fragile, technology dependent, and traditional individuals with intellectual and developmental disabilities.



### 4. RFP DEVELOPMENTS AND ANALYSIS

In June 2021, the state announced its intent to award the state's Medicaid expansion managed care contract to Blue Cross Blue Shield of North Dakota. The contract is for three years with up to two one-year renewals, and began on January 1, 2022. Current incumbent Sanford Health Plan serves approximately 26,000 expansion members.

The state released request for proposals (RFP) in May 2023 for a Medicaid Enterprise Technical Systems Integrator to modernize existing integration platforms, implement modern integration, and identify and access management capabilities. Awards will be announced March 2024. The contract is set to begin on April 8, 2024.

# 5. MEDICAID FEE FOR SERVICE VS. MANAGED CARE PENETRATION

Total Medicaid enrollment in North Dakota was 130,665 in 2022. About 25.8% of Medicaid beneficiaries were enrolled in a managed care plan. The remainder are in fee-for-service Medicaid. Total Medicaid expenditures were \$1.5 billion in 2022, with about 27.9% through managed care and the rest through fee-for-service.
